# What has the **Biden/Harris Team** done to combat climate change?

Most significantly Biden signed the Inflation Reduction Act in August of 2022. The law invests hundreds of billions of dollars in clean energy, electric vehicles, environmental justice and more.

The administration has tackled the problems of super pollutants such as hydrofluorocarbons (HFCs) and methane which are emitted in smaller quantities than carbon dioxide, but pound for pound trap much more heat. The Senate ratified the international Kigali Amendment on reducing HFCs in September 2022, and U.S. Environmental Protection Agency (EPA) has issued regulations to phase down HFCs. In November 2022, the Biden/Harris administration released an updated Methane Action Plan, which includes 50 specific measures backed by \$20 billion in funding.

This year, the EPA finalized strong passenger vehicle standards for vehicle models beginning in 2027 that will cut climate pollution from new cars and light trucks in half by model year 2032 compared to 2026.

The United States has rejoined the Paris Climate Agreement which we originally signed in 2016, but from which we subsequently pulled out under past administrations. By rejoining the US has reaffirmed its commitment to being a leader, not hindrance, in the fight against climate change.

What has the Biden/Harris administration done? In a word... Much.

#### A word from the Chair (continued)

Whole cities would be gone. In areas not directly devastated by a nuclear blast, thousands of burned, broken, and distraught victims would come pouring in, searching for help. Power grids would be destroyed, water systems gone, highways damaged and jammed with disabled vehicles. Any needed supplies would be quickly depleted, and civic functioning would collapse.

International physicians realized that people would turn to them expecting help, but it would be too late. The only option was to stop the arms race and ban nuclear weapons. PSR was started by physicians, but our group includes as many members outside the medical community as we have in it. Our goal is to engage every thinking person in the fight to free us from the threat of nuclear annihilation. We join hands with many other groups in the work ahead. One important goal was reached when the UN General Assembly ratified the Treaty on the Prohibition of Nuclear Weapons. They are now officially illegal under international law. The nuclear armed nations have so far refused to recognize the treaty, but we continue to work on pulling back from the brink. Here's how you can help:

Contact our senators and your representative by e-mail or through the Washington Switchboard (202) 224-3121\* and ask them to support the Back from the Brink call to Prevent Nuclear War by:

- renouncing the option of first use of nuclear weapons
- ending the sole, unchecked authority of any President to launch a nuclear attack
- taking US nuclear weapons off hair-trigger alert
- cancelling plans to enhance our entire nuclear arsenal
- actively supporting verifiable nuclear arms agreements among nuclear states

Ask your representative to sign on as a co-sponsor of HR 77 which calls on the US to lead a global effort to prevent nuclear war.
